Cody Shooting Complex Annual Membership

- An annual membership covers the person named, their spouse and their children under the age of 18, who are full-time students.
 - Anyone under the age of 18 must be supervised by an adult.
 - No one under the age of 8 can handle a firearm on range property.
- Annual memberships expire on June 30th of each year.
- Memberships are NOT prorated.
- New memberships are \$135. This includes one gate card. Additional gate cards may be purchased for \$10.
- Renewals are \$125 and are the responsibility of the holder to process prior to June 30th.
- Any membership not renewed by June 30th will have their cards deactivated on July 1st.
- Lost gate cards must be reported immediately. There will be a \$10 charge for a replacement card.
- Gate cards may not be provided to anyone not covered by your membership.
 - Per range policy the following will occur if it is found that your gate card is being used by someone else:
 - First Offense: Member and Nonmember notified of the violation.
 - Second Offense: Member and Nonmember suspended from the range for a three-month period.
 - Third Offense: Member and Nonmember suspended from the range for a one-year period.
- Any events or special groups must go through an approval process. The required form can be found online or picked up at the Trap and Sporting Clays venues during their open hours.
- There are times when ranges/courses are closed due to special events or maintenance.
- Want to be more involved? Unless noted, Board meetings are held on the second Tuesday of the month, at 6pm in the Trap clubhouse. Members are encouraged to attend and provide input.

General Range Rules

1. Anyone on range property must be a member, purchase a day pass, be participating in an approved special event/group or be there as an approved hired service.
2. A membership is valid for the person listed, their spouse and their children under the age of 18, who are full-time students.
3. All non-venue hosted events and special groups must go through an approval process.
4. Anyone under the age of 18 must be supervised by an adult.
5. No one under the age of 8 can handle a firearm on range property.
6. Alcohol consumption is limited to the camping area.
 - a. Anyone under the influence of alcohol or drugs, including some prescriptions drugs may not handle firearms, nor be on any course or firing line.
7. Smoking and vaping are restricted to designated parking areas and private vehicles.
8. Absolutely no fireworks or explosive targets are permitted on range property.
9. Only service animals are permitted in buildings.
 - a. Dogs shall not run free and shall be tethered or on a leash.
 - b. Pet waste must be removed and properly disposed of by the pet's owner.
10. The Range Safety Officer has absolute authority on the range.
11. Report safety violations and unsafe conditions to any Venue Manager or Board Member.
12. Always follow Basic NRA Safety Rules.
 - a. Always keep the muzzle in a safe direction.
 - b. Always keep your finger off the trigger until you are ready to shoot.
 - c. Always keep the firearm unloaded until ready to use.
13. Always follow venue specific rules.
14. Be thoroughly knowledgeable of the operational and safety features of all your firearms.
15. Before firing your firearm, be sure it is in good working order and that the bore is free of obstructions.
16. Only use ammo recommended by the manufacturer of that firearm.
17. Be certain the ammo matches the caliber of the firearm.
18. Shotgun ammo may only have a shot size of 7 ½, 8, 8 ½, or 9.
19. Be cautious of reloaded ammo.
20. All firearms, except holstered handguns, must be unloaded unless on the firing line.
21. Unload all firearms; clear and open all actions during "Cease Fire".
22. Do not handle firearms during a "Cease Fire".
23. When on the firing line only have the caliber of ammo for the firearm which you are using.
24. Be aware of your actions and the actions of your fellow shooters.
25. Eye and ear protection is required when at or near a firing line where shooting is occurring.
26. Clean up your firing point, place targets in trash containers, and return target frames to the proper storage site.
27. All brass and hulls must be picked up by the shooter.
28. Archery is not permitted on range property.
